# KAHNAWÀ:KE CURFEW LAW

Title

K.R.L. c. C-3

[Enacted by By-law #1A on 8 Tsothohrkó:wa/January 1966] [Amended by MCR # 2/2025-2026 on 9 Ohiaríha/June 2025]

Preamble

WHEREAS the Council of the Caughnawaga Band of Indians at a meeting held January 8th 1966, makes the following by-law pursuant to paragraphs (c), (d), (q) and (r) of Section of the Indian Act; and,

## **SECTION I**

"Purpose"

## 1. **PURPOSE**

1.1 A by-law to provide for the regulation of the activities of boys and girls on the Caughnawaga Indian reserve actually or apparently under 16 years of age.

"Application"

## 2. APPLICATION

2.1 No boy or girl on the Caughnawaga Indian Reserve actually or apparently under 16 years of age, shall loiter any place within the said Indian Reserve after nine o'clock in the afternoon.

#### **SECTION II**

"Prohibition"

#### 3. **PROHIBITION**

3.1 No boy or girl on the Caughnawaga Indian Reserve actually or apparently under 16 years of age, shall be in any place of entertainment, street lane, by-way or common within the said Reserve, or shall be in the course of returning from any place of entertainment off the said Reserve after the hour of nine o'clock in the afternoon unless accompanied by his or her parent or an adult appointed by a parent to accompany such child.

# **SECTION III**

"Penalties"

## 4. **PENALTIES**

4.1 A boy or girl on the Caughnawaga Indian Reserve found violating the provisions of paragraph (a) or (b) may be warned and conducted home by a police officer, (R.C.M.P. Officer or Indian Constable).

4.2 A parent who permits his child to violate paragraph (a) or (b) shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding \$5.00.

## **SECTION IV**

"Coming into Force"

## 5. **COMING INTO FORCE**

With the coming into force of this by-law, By-law No. 1 made by the Council of the Caughnawaga Band at a meeting held January 11, 1964 to provide for the regulation of the activities of boys and girls on the Caughnawaga Indian Reserve actually or apparently under 16 years of age, shall cease to be in force.
