Regulation #6 - Regulation Respecting the Registrar of the Kanien'kehá:ka of Kahnawà:ke Law

- -KKR applicant names are not published when they apply-Very clear in the CDMP process, question is why and when it changed.
- -Registrar and Compliance Officer determine whether they are in conflict of interest. There should be others in the office who can determine as well.
- -In the definition of 'Related' for the purposes of conflict of interest, it can be reworded to say "Current and former spouses/relationships and list the types of in-laws included

Regulation #7 - Regulation Respecting Applications for Recognition

- -In relation to the dependent children in foster care, are foster parents considered guardians who can make an application on the KKR.
- -Should a qualifier for birth certificate on the checklist to identify that parental information must be included.
- -'Other Proof' is too vague, be specific as to what other proof is....Could be anything.
