2. CDMP PROPOSED REVISIONS UPDATE/DECISION

A) Regulations Policy & Flowchart

Revisions proposed by the working group were presented to the KLCC for discussion.

SUGGESTION \rightarrow Next time policy is amended or reviewed, 3.34 should include the list/legislative tracker used for enacting laws rather than referring to elsewhere.

B) Revised Flowchart

Discussion regarding Community Member Observer as part of the TDC for Regulations

- o Agreed to have Community Member solely as an Observer on TDC
- o Selection/criteria to be further discussed and determined amendment to be reflected in the Regulations

3. KLCC Update

A) Quarterly Review/Update on Law Submissions – Update provided regarding Laws currently on the Legislative Calendar/Agenda

KRL/KKL – The following update was read aloud to KLC:

"The Kahnawà:ke Residency Law was passed in 2019 using the KLCC Urgent Law-Making Process. It hasn't been fully implemented at the present time as there remain outstanding regulations currently in development at Justice Services. At this point, it is expected that the new regulations will proceed through the KLCC process during the summer months and the KRL can be fully implemented by September.

Alexis Shackleton has instructed that the KRL will function for at least 6 months before a complete review is done, leading the process to January 2023."

Tobacco Law – Unique since no type, but normally would be Type II

- TDC is in discussion with KTA concerning wording in some clauses
- Not ready to schedule a hearing
- Background info:
 - O Has been in the CDMP since ~2014 and was already passed in its entirety by consensus after several hearings then had to go through a legal review
 - o Legal issues were flagged because it had far-reaching provisions that would have legal implications
 - O Was addressed with the Tobacco Association members that were a part of the working group and now must go back to a full community hearing
 - Last term began re-engagement with KTA collaboratively and re-named joint working group as, 'Tobacco Law Drafting Group'
 - Some suggested changes were made, and another meeting is potentially scheduled for May 18, 2022.

Elections Law

- No movement on the part of the Executive Office because person responsible is on leave
- Will discuss with Executive office to have a TDC established target date May 2022.

Animal Control Law

• Info provided by KLCC Coordinator and explained how the process works. Outstanding item was to go to Council to get the Mandate, Purpose, and Scope. Once complete the Front-End work would resume (talk shows, PSAs, news releases, etc.).

Occupational Safety and Health

- Person responsible is on leave
- Had an MSI strategy meeting with Lead Port. Chief and Port. Chief and MSI
- The new plan is to invite business owners to the Tewa building and provide Q&A sessions.
- Arranging to have KTV make a video, a radio talk show, and invitations were sent out to individual business.

B) Waiting List

- Update on recent submissions (Gaming Law & Right of Way Law)
- Gaming Law: request & acknowledged
- Right of Way Law: request, acknowledged. Not categorized until ready to go to Council to confirm categorization.
- Need to consider Covid situation and process being put on hold during that time
