July 18, 2023	My only concern on the revised law are the sections that talk about euthanizing an animal. I feel this should be a last resort unless the animal has caused bodily harm to a person. Also, can you elaborate on what is considered a Dog of Concern or a Prohibited Dog?	Euthanasia is a last resort and is determined on a case-by- case basis. There is a prohibited dog but that is not based on a breed but rather a decision made on an individual dog based on its behavior. Regulations will be drafted to address the criteria for this. In section 22 there is mention of a prohibition of breeding vicious or aggressive animals as well as a prohibition to own or possess any animals listed in schedule B. The prohibition on breeding may be detailed in a regulation or left to the discretion of the Animal control. As for Schedule B, it has yet to be drafted.

This does not relate to the breed of dog but rather a decision made on an individual dog based on its behavior. Regulations will be drafted to address the criteria for this. The allocation of operational resources and appropriate human resources are considered as part of the planning considerations prior to enacting the law. In addition, there is a yearly review of review of resource allocation and planning by PSD prior to each budget year. There are 'on call' Animal Control Officers available after 4 pm and the Peacekeepers may be contacted 24/7 if ever you cannot contact Animal Control.

Or forgotten dogs), egg layer (chickens), and meet birds (chickens). My concern is what if I am at work/school and somebody calls just to be a jerk and it's that one time that my dogs are barking too much or they get out of my yard (I have a fence up) and now I'd have to retrieve them from animal Protection (with a certain amount of time with the amount of money) I have to pay, then I have to get a license, then I would have to do this and then I would have to do that. I'm not rich, I make sure that my animals are well taken care of but with this law it would make it difficult for me to get my dogs out in a timely manner. I will not chain up my dogs. I have a fence. And what if you give me a certain amount of hens I can have, which isn't right because there's a number of eggs, you're saying me and my kids can eat, what I can donate, I can give away or even sell. The same thing goes for my meat chickens, I don't think you should give a number on how much I can have to provide for my kids and myself and then if I decide I want to do a workshop on how to process them I will need a permit (for everything). We're not white! We have our right to eat, hunt and raise our food. If the council is trying to fight for our hunting rights, why is the council putting these restrictions/permits on us (or allowing it)? The animal law needs to have some laws put in; I agree. You all need to work out a different animal law that fits us, Mohawk people.	This law attempts to strike a balance between the rights of an animal owner and the safety and enjoyment of the community. There is discretion given to the Animal Control Officer and processes for review of any decisions. There is currently no limit on the number of chickens you can have. Rather, focus is placed on ensuring the well- being of animals and the safety of the community.
