

WE NEED YOUR FEEDBACK

After consulting with the community over the past four years, it has been identified that the Community Decision Making Process should be shortened and a Regulations Process be developed, which is **presently** delegated to a Board, Commission or entity within the law to create Regulations.

The Kahnawà:ke Legislative Coordinating Commission (KLCC) has created a **Regulations Process** and is proposing these **revisions to the Type I & II Process**.

Type I (Fundamental affects everyone) Revisions:

- 1) **Phase I** - Political Assessment is done by Council. (NEW – Increased accountability by Council)
- 2) Front End work and research is done sooner and includes consulting with stakeholders.
(Should result in improved efficiency in determining whether or not community supports a mandate to proceed with a law or amendments to a law)
- 3) Elimination of the Intent while maintaining the Purpose & Scope
(Redundant – decision to eliminate Intent because of similarities to Purpose)
- 4) **Phase II** - Limited Timeframe of 6 months for every law (Addresses concerns regarding length of Process)
- 5) Elimination of the Third Hearing replaced by the Formal Reading where the law is read into the record. (For improved efficiency, the Third Hearing was deemed unnecessary since the law is reviewed by community in full after Second Hearing)

Type II (Regulatory in nature – affects segment or special interest group) Revisions:

- 1) **Phase I** - Political Assessment is done by Council (NEW – Increased accountability by Council)
- 2) Elimination of the Intent while maintaining the Purpose & Scope that the community confirms
(Redundant – decision to eliminate Intent because of similarities to Purpose)
- 3) **Phase II** Created Draft Law Hearings (limited timeframe) where the law is brought to the community for feedback then redrafted by Drafting/Technical Team. (Addresses concerns regarding length of Process)
- 4) Elimination of Second Reading and move to Final Reading where the law is read into the record
(For improved efficiency, the Second Reading is deemed unnecessary since the law is drafted based on consultation w/stakeholders then presented to the community in the Draft Law Hearing (limited #) stage.)
- 5) Result: Certification of the Process is signed by the KLCC Coordinator, KLCC Community Representative(s), Technician and Portfolio Chief(s) instead of the Technician and Portfolio Chief(s).
(Increased accountability by community representatives & KLCC)
