Justice Act	First Hearing Mid-August
MRI	Information to the community to start this summer before scheduling of first community consultation in mid-July. KLCC to resubmit to be re-categorized from a Type I to an Urgent Law.
Membership Law	Cancellation of 9 th community consultation due to low attendance. Next consultation: June 6, 2013. Utilizing observer tables.
Elections Law	Draft Law with track changes to be posted online for 60 days. Should be ready for First Hearing of Draft Law in September 2013.
Alcoholic Beverages Law	Board reviewing amendments. To be resubmitted to go through the CDMP within one (1) month.
Tobacco	The proponents need to clarify a few questions before their request can be categorized and so that Legal Services could get a better indication of the Purpose, Scope & Intent: -The Chiefs want this issue bought before the people under the CDMP for legislation to be adopted and they feel this should be done urgently . Why would it be considered Urgent? It was noted that Bill C16 was just passed through the Senate for amendments to this law would happen quickly.
Land Code & Kariwakweniéntshera Law	No movement. Questions: Will Council be reviewing this request? Considerations: -May 28, 2012 - Record of Decision – Chief and Council denied request for technician to be assigned because of concerns with the timing of the proposed law given the KCR Process on lands developing and the status of the Justice Act. Response: Yes this will be discussed during July's Lands Portfolio Chiefs session
