<b>1. Previous Record of Conclusions</b>	DRAFT ROC 01/15/14 – Finalized by 4:00 p.m. today if no suggested changes received.
<b>2. File Updates</b>	<p><b>Justice:</b> Last night's Hearing was successful as we were able to complete the 2<sup>nd</sup> Draft of the Kahnawà:ke Justice System. Ron will be working on preparing a budget before it goes for enactment, which should take place in mid-May – early June 2014. Kahente noted that she responded to a community member's e-mail to set the record straight regarding non-native reporters from The Eastern Door attending CDMP Hearings.</p> <p><b>MRI:</b> Next Hearing tentatively set for Tuesday, April 29, 2014. Joe reported that the MRI Draft is completed and ready to be released to the public. There will be commercials on KTV advertising the law and upcoming Hearing.</p> <p><b>ACTION: Contact Paul Nicholas for copy of Draft MRI Law posting on KLCC website (<a href="http://www.kahnawakemakingdecisions.com">www.kahnawakemakingdecisions.com</a>).</b></p> <p><b>Membership:</b> Next Consultation tentatively scheduled for April 1 &amp; 15, 2014. However, it depends on the date that MRI picks for its next Hearing. Need to receive mandate, determine PSI and choose 3 community representatives.</p> <p><b>Elections:</b> Tentative Date Next Hearing: March 25/14. Technician will be holding a kiosk to poll community about using blood quantum for electing Grand Chief.</p> <p><b>Tobacco:</b> Waiting for their re-submission letter. It was suggested that KLCC drafts a Press Release in relation to rumors circulating within the community about KLCC not having the money to see the Tobacco Law through the CDMP. Kahente will prepare a draft for KLCCs approval.</p>
<b>3. Strategic Planning</b>	Kahente scheduled meetings with KLCC for the review and feedback on the draft report and gave an overview of the report. Discussion on participation being the main problem and how the Indian Act System is not designed to handle the CDMP.
<b>4. Other</b>	Kahente will draft procedures for development of regulations to be inserted in the KLCC Procedural Manual as to when it was passed, and she indicated that she will keep a section in the back to add in procedures.
