2) Kahnawà:ke Election Law Community Consultation

- Review of draft minutes from the Community Consultation Hearing
- Next Steps: Post minutes on website and give direction/feedback to Technician
- Consolidation of information from the hearing would be Trina's responsibility and to put that into a theme with the commonalities (i.e. criteria, education). Put this back out to the community for comment and provide further recommendations. A lot of what was discussed pertained to the administrative issues rather than the real issues. Second question was too specific; should have been more open ended. Information only based on feedback received.
- A lot of discussions pertained to process
- Separate law from regulations
- Do we want to ask the people if they want to call them Counselors rather than Chiefs?

Suggestions:

- KLCC assumes responsibility to ensure participants have clear picture of their expectations to bring the legislation forward through the CDMP so that is discussed effectively.
- Meet with Trina to guide her in the right direction and offer assistance to develop questions
- Narrow recommendations down- anything else?
- Set priorities – detail – next question – membership's priority – only 5 - 6 recommendations
- Harmonization of laws - Election Law follows the Membership Law
- The proponent also has to champion the law, to get up and to speak. In this case it would be Lori Jacobs.
- To ensure that there is equal representation from the Chiefs in all three groups.
- Rethink what KLCC responsibilities are

Decision:

-It was agreed to meet with Trina to assist her with developing the final question and the presentation for next Community Consultation Hearing. If she feels comfortable with us taking the lead to set the stage, we'll open the hearing to explain the hearing's purpose with regards to the Election Law amendments, but not as the lead resource person. That is her function.
