2) Kahnawà:ke Election Law Community Consultation

- Decision not to use feather as talking symbol
- Objective awareness requires more coordination with proponent and facilitators. Important that facilitators understand what we want to achieve.
- Use of jump stick to copy Group 1 responses for Group 2 & 3 to compare answers.
- Use of sound system required

Technical Team:

- Technical Team will be comprised of Technician (Trina C. Diabo), Legal Services Representative, three Community Representatives (Angus Montour, Matthew Stacey & Lori Jacobs) and Shari Lahache from Social Development Unit. Preferably from Membership.
- Legal drafts law
- Trina gathers information and assists Legal Representative to draft law. The Community Representatives are brought in for approval of the amendments to the Election Law after they are made by Trina and the Legal Rep.
- It was questioned by a community member whether Lori Jacobs' role on the Technical Team is valid because she may be considered an MCK employee on the Gaming Commission. Kahente will follow-up with Legal services.

Discussion about criteria to run for Chief and 50% blood quantum requirement was addressed with further discussion that the law should be designed in a certain way to insert Regulations. Those Regulations would be easier to change and must be consistent with the Membership Law. Give law opportunity to work for the benefit of the masses. Consideration should be given to the least advantaged.

3) File Updates

Anti-Tobacco:

- Community Consultation end of April
- Any requests for submitting proposed legislations should be referred to KLCC Coordinator to ensure we do not form the content of proponent's request, but only facilitate the process.
- Cannot 'piggy back' a request for Tobacco Law. Has to go through CDMP; need checks and balances. It's Regulatory and may be categorized as Type II. Need to engage community in advance for their input. Council may say as long as it protects community. Need the voice of the people.
- Can engage community in advance asking them what they think the PSI should be. Engage in advance and get an agreement of what it should look like, then go through the Process.

Justice:

- Justice Act Technical Team meeting tonight and next Thursday to review and accept draft changes.
- Technical Team should be ready to go to first Community Hearing once they've approved changes.

Sanitary Conditions Law (SCL):

- Legislative session for enactment of SCL Monday, April 2, 2012
- Acquiring signatures for Council Agenda Package and KLCC Legislative Tracker
