The Animal Protection Department is scheduling their community consultations for the end of November using a survey to gauge the community.

3. File Update - Review & Decision

Legislative Calendar – All

Final revisions were made to the calendar with the following additions: 1) Creation of a Kahnawà:ke Labor Law, 2) Amendment to the Kahnawà:ke Health Care Professions Law, 3) Amendment to the Kahnawà:ke Justice Act, and 4) the Incidental Amendments pursuant to the enactment of the Justice Act.

Repeal Process – All

Upon further review it was decided that perhaps additional steps were needed to the flow chart and more revisions were also needed to the Process.

ACTION: A working group was created comprised of Tonya, Ross & Leslie to work on redrafting the process and flow chart.

Evaluation of CDMP – All

It was clarified that the evaluation was not on the Process, but to determine how KLCC would evaluate the CDMP.

ACTION: Schedule a separate KLCC meeting in the New Year to address the evaluation.

Section 8.2 Procedure for Multiple Requests for Legislation or Amendments to Existing Legislation – All
