1. Administrative – Review/Decision

Record of Conclusion 11/01/2018 - The ROC was approved by Joe Delaronde and seconded by Ratsénhaienhs Ross Montour.

2. <u>Laws Update – Review</u>

Proposed Draft Kahnawà:ke Residency Law – Leslie Skye

There may be a change with the Portfolio Chief. To be confirmed at the next Council Meeting.

Proposed Draft Kahnawà:ke Cannabis Control Law - Leslie Skye

The Formal Reading took place on December 4, 2018. The enactment is scheduled for December 10, 2018.

Amendment Kahnawà:ke Animal Control Law - Leslie Skye

The Animal Protection Department used a different process to conduct their survey to gauge the community. They had five stations for people to write responses to problematic areas within the law that require amendment. Non-threatening and a good tool to use for people who aren't as vocal. Completion of Phase I will resume in the New Year. Also noted was that an MCK lawyer has yet to be assigned for this Law from Legal Services.

3. File Update - Review & Decision

CDMP - All

- a) Confirmation of the Will of the People Discussion on whether we should continue to use for Type II Laws. This was a carry over from the Type I Laws, although Council carries the voice for the people. It was noted during the Portfolio Mandate meeting that if the community was engaged enough in the Front End of the Process then you have confirmation.
- b) Declaration of Conclusion The Process Flow Chart doesn't fully reflect what is meant by the Declaration of Conclusion in the CDMP Procedural Manual. It shouldn't be a form; but done orally because its purpose is to conclude the Hearings phase. We also post a press release online to ensure that the community is aware that the Hearings phase has been closed.

ACTION: Leslie to add more detail about the Declaration of Conclusion in the Procedural Manual.

c) CDMP Name change – Some community members feel it's not a community decision making process because they don't have enough say with a Type II Law. It was also suggested to change it to a Standing Committee format, where the amended law is posted, and a date is set for the community to ask questions and to provide feedback. Assign a time limit for each community member to voice their opinion.

- d) Formal Reading As it has always been an option to film the law being read into the record, it was agreed to continue with this format when feasible due to the high cost and low attendance of past Readings. The content of the law is completed since there is no additional feedback accepted at that point.
- e) No Draft Law Submissions Agreement was reached that KLCC would no longer accept draft law submissions. *ACTION:* Leslie to update the Procedural Manual to state that the KLCC will no longer accept draft laws.

 Evaluation of CDMP – All

It was agreed to further discuss revising the CDMP in the New Year.
