1. Previous ROC REVIEW/APPROVAL	<ul style="list-style-type: none"> Approval of 4/7/2016 ROC Approved.
2. FILE UPDATE REVIEW/DECISION	<ul style="list-style-type: none"> Election Law – Kevin (2 min.) Kevin will be working with Lana Snow in May to compile a listing of required changes and recommendations to the Law. It will be presented to KLCC. No tentative date was given. Tobacco Law – Bobby (10 min.) Clarification that this Law is still being put through as an “Urgent” process and therefore will require only one Hearing. Rescinding/ Repealing Laws – Kevin (20 min.) KLCC should definitely have a role in all aspects of Legislation. The details of criteria for rescinding or repealing laws are to be developed. It was agreed that KLCC members will email Leslie and Kim their ideas on criteria to be adopted before the next meeting. Regulation Procedural Manual (as an addendum) <ul style="list-style-type: none"> Approval CDMP Regulation Process flow chart It was agreed that SOD is to be contacted to hold key stakeholder (proponent) consultations before finalizing this process for review and approval by Chief and Council. Chief Kahsennenhawe Sky-Deer, Leslie Skye, and Kim Beauvais will follow up on this. Membership – Kahsennenhawe <ul style="list-style-type: none"> Regulations ratification issue/concern – See above re: SOD consultation. Discussion: The KML was supposed to be an “amendment” not a revision of the law in its entirety. There was a question about the possibility of changing the mandate for amending this law. The process is taking too long, as people have been waiting to be able to be included on the KKR. It was determined that the process cannot be changed mid-stream. However, to expedite the process, it was suggested that a “rolling draft” to show changes where consensus has been already been reached that affect other sections.

Due to an unprecedented heavy workload, Communications felt that it would be best to proceed in late spring/early summer when things are expected to be more manageable. CDMP Procedural Manual Chief Kahsennenhawe Sky-Deer and Kim Beauvais will meet on May 10th to determine where the working group left off and to update the manual as a “rolling draft” to correspond with the flow charts being presented to Chief and Council.
