	<p>Proposed Kahnawà:ke Residency Law – Chief Kahsennenhawe Sky-Deer As part of the Front End work, an opinion poll (survey) is being conducted. A copy of the survey will be sent to KLCC. Joe Delaronde will assist with the Communication Plan.</p> <p>Kahnawà:ke Family Homes Law (KFHL) - Leslie Skye A meeting was held with the TDC to discuss the Front End work for the KFHL. A communications plan is forthcoming and will include Kiosks at the Services Complex and with organizations throughout the community. A review of the RODs will be done by the TDC to help determine the Scope of the law through the Regular Type I CDMP.</p> <p>Kahnawà:ke Tobacco Law – Leslie Skye A meeting was held this morning between the MCK/KTA Working Group and members of the KLCC to inform the KTA that before the Draft Kahnawà:ke Tobacco Law could move forward in the CDMP, they had to finish reviewing the Legal Summary. The KTA Working Group was given the authority by the KTA to make decisions on their behalf. Also discussed was the fact that the Implementation/Operation/Financial Plan was incomplete. Decision: <i>The Draft Tobacco Law will not move forward until the KTA Working Group completes a review of the Legal Summary and they resubmit their Implementation/Operation/Financial Plan for presentation to C & C.</i></p> <p>Kahnawà:ke Membership Law – Chief Kahsennenhawe Sky-Deer The TDC met to review the Legal Assessment. A reminder was sent to the TDC to begin preparation of the Draft Membership Law's Implementation/Operation/Financial Plan.</p> <p>Kahnawà:ke Sanitary Conditions Law (SCL) – Leslie Skye Since the SCL was part of the 2015 – 2018 Legislative Calendar, a letter was sent to Melanie Gilbert requesting a meeting to discuss the 5-Year Mandatory review of the SCL; however the meeting was cancelled due to a scheduling conflict and will have to be rescheduled. As part of S.O.D. Action Plan, the</p>

Lands Unit sent a request to KLCC to confirm in writing that there was no official Regulations Process. Leslie informed that she sent a letter of confirmation.

3. Five-Year Mandatory Review – Leslie Skye

The tracker was developed mainly because the Sanitary Conditions Law was up for its 5-year mandatory review as of April 2, 2017 and also to keep track of which laws required amendments. Ideally this should be done at the onset of each election and presented to the Chiefs. While it was identified that it was not KLCC's responsibility to follow through with a process but only to notify the Chiefs that their laws were due for a 5-year mandatory review, it was suggested that perhaps the Tracker could be given to OCC to be managed. It was also suggested that the review of laws be staggered. It was further suggested to hold one Hearing to pass several laws that had non-substantive amendments. Joe Delaronde requested an electronic copy of the Five-Year Mandatory Review tracker to get the process started.

Decision: Leslie - send Joe Delaronde and Winona Polson-Lahache an electronic copy of the Five-Year Mandatory Review Tracker.

4. Other – Kevin Fleischer

How long would it take for amendments to the Election Law to be put through the CDMP? This is difficult to give a timeframe with five laws currently going through the Process. It was suggested to submit the request as quickly as possible if the TDC for the Election Law hopes to have amendments before the end of 2017. It was also suggested that the amendments to the Election Law be completed and passed by December 31, 2017 in order to allow time for preparation and education before the 2018 MCK Elections.
