Administrative</p> <ul style="list-style-type: none"> • Approval ROC: The previous Record of Conclusion of 05/04/2017 was approved. • Oversight KLCC Coordinator & Administrator: After a brief discussion, it was agreed to defer this agenda item until the next regularly scheduled KLCC meeting on September 7, 2017 when the OCC Representative (Winona) is present to provide input. • Terms of Reference Organizational Representative: A working group comprised of Joe Delaronde, Kevin Fleischer & Leslie Skye has been set up to develop a terms of reference for the Organizational Representative position. A deadline of September 7, 2017 has been given to complete this task for approval by KLCC at the September 7, 2017 regular meeting. <p>2. Laws Update</p> <ul style="list-style-type: none"> • Kahnawà:ke Residency Law - Chief Kahsennenhawe Sky-Deer A tentative date of has been set for the end of July to complete the draft law. There are some adjudication questions that were raised. It is expected that the drafting committee will be consulting with Public Safety and Justice Services prior to posting to the community. A question was asked about how the Drafting Committee would include the options for ‘<i>People registered with Canada, with some lineage and grew up in Kahnawà:ke</i>’, as was agreed at the community consultation. • Kahnawà:ke Membership Law – Chief Kahsennenhawe Sky-Deer The entire law has been reviewed by the Technical Drafting Committee. Currently working on drafting options for the definition of Great Grandparent and now would have to go back six generations to verify if the great grandparents were at least 50%. The problem is that the term “<i>some lineage</i>” is being left open to interpretation. The other issue that would require clarification from the community is the Adoption section. The law is expected to be posted online for 30 days by the end of July 2017. A question was asked about what difference it made having a Residency Law as opposed to just having a Membership Law with the residency sections included in the law. It was explained that: 1) a residency law would remove non-natives; 2) people not on the KKR still living here but have lineage and children have married back in would now be able to stay; and 3) Non-natives are squatting in Kahnawà:ke, but now with a residency law it can be adjudicated within the Court of Kahnawà:ke and enforced by the Kahnawà:ke Peacekeepers or other empowered individuals. • Kahnawà:ke Family Homes Law (KFHL) - Leslie Skye A decision was made to contact Chief Clinton Phillips (Portfolio Chief) and Paul Nicholas (Technician) to set up a meeting to discuss the lack of movement with the law. • Kahnawà:ke Tobacco Law – Chief Robert Patton The MCK/KTA Working Group has been meeting to discuss the legal review, developing regulations, hiring inspectors, etc., with a meeting scheduled next month between the Kahnawà:ke Labor Office and the MCK/KTA Working Group. Also discussed the differentiation of responsibilities between Health Canada and Public Safety pertaining to the Tobacco Industry. • Kahnawà:ke Alcoholic Beverages – Chief Bobby Patton Discussed the lack of quality control between SAQ, Health Canada and Kahnawà:ke for the production of alcohol partly because of the expertise to conduct inspections and not having an agreement between all three parties. A meeting has been arranged between SAQ, Health Canada and a working group to include ABC Board members to discuss the manufacturing and distribution of wine and spirits and the development of some sort of an agreement 	

- **Kahnawà:ke Elections Law – *Kevin Fleischer***

The Drafting Committee has continued its work amending the law. Unsure of current status of draft law and uncertain if it would go through the Process in time for next year's election. The concept of bringing more than one law at once for amendment through the CDMP was discussed as well as the need for the KLCC to further revise the Process by tightening up the timelines for all laws going through the CDMP.

- **Kahnawà:ke Sanitary Conditions Law (SCL) – *Leslie Skye***

The Drafting Committee met and decided that they would not be amending the entire law and a political assessment would be done by Council through the OCC.
