1. ADMINISTRATIVE - REVIEW/APPROVAL

The Previous ROC dated 05/10/2017 was reviewed and approved.

2.LAWS UPDATE - REVIEW/DECISION

• **Proposed Amendment to Animal Control Law –Ron Skye**

The amendment to the Animal Control Law has been officially categorized as a Type II Law, and will be going through the Regular CDMP. The Law is currently in the very early stages of the CDMP and a technician has not yet been identified. Since this law falls under the responsibility of the Public Safety Unit, it will be up to both Ron and Arnold to assign a technician.

ACTION: Ron/Arnold to assign a technician for the Animal Control Law.

• **Proposed Kahnawà:ke Residency and Kahnawà:ke Membership Law – Leslie Skye/Jean Pommainville**

Both the Residency and Membership Law Technical Drafting Committees were scheduled to meet on October 13, 2017.

At this time, the Residency Law is still being drafted, and there are still some concerns with regards to its enforcement.

The Community Representatives on the Drafting Committee were given a deadline of November 1, 2017 to submit their comments to the Draft Law. Thus, the Final Draft of the Kahnawà:ke Membership Law has been completed and is ready to go out to the community upon Kahsennenhawe's return. It was also mentioned that there are options in regards to the definition of the Great Grandparent written in the margins of the Draft Law.

• **Kahnawà:ke Family Homes Law – Leslie Skye**

The technician on the Kahnawà:ke Family Homes Law informed that he is currently conducting a preliminary political assessment, and the target date for completion is November 10, 2017.

In addition, Clinton and Winona are scheduled to return to a Council Meeting on November 13, 2017 in order to ask the Chiefs for direction with the Law; whether they will be asking the new Minister to reconsider their decision to accept the KFHL or not, and also request that the Law be transferred to another Unit.

• **Request for Kahnawà:ke Cannabis Act and Kahnawà:ke Cannabis Control Law – All**

KLCC has received two legislative requests along with two Draft Laws regarding the regulation of Cannabis in Kahnawà:ke. The first request came from community member Jeremiah Johnson on October 10, 2017. The second request came from Murray Marshall on behalf of the MCK Cannabis Working Group on October 25, 2017.

It was collectively decided that KLCC must outline a procedure that specifically deals with receiving multiple requests

and multiple draft laws for the same proposed legislation.

A thorough discussion ensued on this issue. It was suggested that in the future, there should be some criteria that a draft law has to meet before it is accepted by KLCC. For example, an individual or group submitting a draft law should clearly outline their Scope in the Law in order to make their intent clear. An individual submitting a Draft Law should also include any information or results they may have from conducting pre-consultations, surveys, kiosks, etc. that pertain to the Law.

This procedure will be outlined in the near future by the CDMP Procedural Manual Working Group. At present, both submissions for Cannabis legislation must be categorized and confirmed by Chief and Council, and further the Technical Drafting Committee must be identified. After such, it was ultimately decided by KLCC that the Technical Drafting Committee should schedule a meeting with Jeremiah Johnson in order to further discuss his submission.

3.OTHER - REVIEW/DECISION

- **Signing of Resolution for CDMP Procedural Manual – All**

The CDMP Procedural Manual Working Group will meet to outline the procedure for multiple submissions.

ACTION: Leslie to schedule a meeting with the CDMP Procedural Manual Working Group to draft a procedure for multiple legislative submissions.

An addition was made to the Manual in Section 8.1:

“Submissions should include a proposed scope, as well as any and all supporting documentation, such as consultation reports”.

A question was also raised about whether or not consensus should be specifically defined in the CDMP Procedural Manual with regards to the hearings. However, most felt that putting a time constraint on reaching consensus at the CDMP hearings was unnecessary.

The CDMP Procedural Manual was then accepted by KLCC, and Resolution No.2 /November 2, 2017 was then signed by the Commissioners.

- **Discussion of Repeal and Regulations Process – Leslie Skye**

A discussion was had on whether or not KLCC should continue to have Working Groups or to discontinue them and develop policies, such as the Regulations and Repeal Processes during the KLCC Monthly meetings.

DECISION: Continue to have the Working Groups since most of the processes being developed are near completion.

The Repeal Process was also reviewed by all of KLCC. There was one change to be made: on page 3 of the Repeal Process package, the acronym “MCED” should read “MCR”.

ACTION: Katsistohkwi:io to make this correction in the Repeal Process package.
